#### CIRCULAR

AMENDING SOME ARTICLES OF THE CIRCULAR NO.01/2016/TT-BVHTTDL DATED 24 MARCH 2016 OF THE MINISTER OF CULTURE, SPORTS AND TOURISM, REGULATING IN DETAILS THE EXECUTION OF SOME ARTICLES OF THE DECREE NO.79/2012/ND-CP DATED 05 OCTOBER 2012 OF THE GOVERNMENT, REGULATING THE ART PERFORMANCE, FASHION SHOW; BEAUTY AND FASHION MODEL CONTEST; CIRCULATION AND TRADING OF SONG, MUSIC, DANCE, STAGE RECORDS, VIDEOS AND DECREE NO.15/2016/ND-CPD DATED 15 MARCH 2016 OF THE GOVERNMENT ON AMENDING, SUPPLEMENTING SOME ARTICLES OF THE DECREE NO.79/2012/ND-CP

Basing on Decree No.79/2012/ND-CP dated 05 October 2012 of the Government, regulating in details on art performance, fashion show, beauty and fashion model contest; circulation and trading of song, music, dance, stage records, videos;

Basing on Decree No.15/2016/ND-CP dated 15 March 2016 of the Government on amending, supplementing some articles of the Decree No.79/2012/ND-CP dated 05 October 2012 of the Government;

Basing on Decree No.76/2013/ND-CP dated 16 July 2013 of the Government, regulating the functions, duties, power and organization structure of the Ministry of Culture, Sports and Touris.

According to the proposal of the Director of Department of Legislation;

Minister of Culture, Sports and Tourism promulgates the Circular on amending some Articles of the Circular No.01/2016/TT-BVHTTDL dated 24 March 2016 of the Minister of Culture, Sports and Tourism, regulating in details the execution of some Articles of the Decree No.79/2012/ND-CP dated 05 October 2012 of the Government, regulating the art performance, fashion show, beauty and fashion model contest; circulation and trading of song, music, dance, stage records, videos and Decree No.15/2016/ND-CP dated 15 March 2016 of the Government on amending, supplementing some articles of the Decree No.79/2012/ND-CP.

Article 1. Amending some Articles of Circular No.01/2016/TT-BVHTTDL dated 24 March 2016 regulating in details the execution of some articles of the Decree No.79/2012/ND-CP dated 05 October 2012 of the Government, regulating the art performance, fashion show; beauty and fashion model contest; circulation and trading of song, music, dance, stage records, videos and decree no.15/2016/ND-CP dated 15 March 2016 of the Government on amending, suplementing some Articles of the Decree No.79/2012/ND-CP (herein is referred to as Circular No.01/2016/TT-BVHTTDL).

1. Article 2 is amended as follows:

"Article 2. Notify the art performance, fashion show, beauty and model contest (regulated in Item 2, Article 1 Decree No.15/2016/ND-CP)

The ones who organize the art performance, fashion show, beauty and model contest send notice directly or by post (Form No.1) to the Department of Culture, Sports and Tourism or the Department of Culture and Sports where the organization is carried out".

2. Article 4 is amended as follows:

# "Article 4. Orders, procedures for license withdrawal (regulated in Item 3, Article 1 Decree No.15/2016/ND-CP)

1. In case of finding out any violation, the competent authority of license revoke shall promulgate for revoke and notify the relevant individuals and organizations.

2. In case of not having authority to revoke license, the agency, organizations that find out the violation is responsible for making minutes and send written petition to the competent authority to revoke the license (Form No.03) for consideration and promulgation of revoke decision (Form No.4). In case of not withdrawing license, must reply in writing and state the reasons."

3. Article 7 is amended in clause 9 as follows:

"9. The expenses for contest organization:

4. Amending the forms following regulated in Article 13:

a) Form No.01: The notice on the art performance, fashion show, beauty and model contest;

b) Form No.09a: License for the foreign organizations, individuals to have art performance, fashion show.

c) Form No.09b: License for individuals who are ovesea Vietnamese to have art performance, fashion show.

#### Article 2. Cancel some articles, clauses, points of Circular No.01/2016/TT-BVHTDL

1. Article 3 on the actions of the ones making art performance, fashion show; the ones that achieve the titles at the beauty, model contests not permitted to be executed, disseminated, circulated.

2. The points a and b Clause 7 Article 7 on the content, form of the beauty, model contest project

3. Item 2 Article 10 on the case of not issuing license for the organization of beauty, model contests.

4. Claue 2, Article 13 on Form No.01: The written consent on notice of art performance, fashion show, beauty and model contest.

5. Clause 15 Article on Form No.14: The written commitment on full implementation of the regulations of the law on the copyright.

#### **Article 3: Clause on execution**

1. This Circular shall be valid for execution from 01 January 2017

2. In the progress of execution, in case of any problem, inquiry, the organizations and individuals can give petition to the Ministry of Culture, Sports and Tourism for research, amendment./.
