- + Owner of the business household organizing the art performance, fashion show.

- Within 3 working days from the day on which the application is received, should the application have not been fully comformable to the requirements, permit-issuing agency must issue written document to request the organization or individual to submit supplementary application.

- Within 5 working days from the day on which the satisfactory application is received, Service of Culture and Sport of Hanoi City organize assessment of the application and submit to the People's Committee of the City to issue permit for foreign organization or individual implementing art performance, fashion show in local areas. If the permit is rejected, a written response containing explanation shall be sent.
