<u>Procedure 9:</u> Grant permit to oversea Vietnamese, foreign organizations and individuals who carry out study, collection of intangible cultural heritages.

# 1. Implementation order:

- Oversea Vietnamese, foreign organizations and individuals who apply for study, collection of intangible cultural heritages shall send the dossier to the Director of Hanoi City Department of Culture and Sports.
- Within 20 working days, since the date of receiving the application, the Director of Hanoi City Department of Culture and Sports is responsible for considering the granting of license. In case of refusal, the reasons must be clearly stated in writing.
